## 5. MEMORANDUM OF UNDERSTANDING

I understand that the California Gang Task Force (CGTF) is comprised of law enforcement personnel as defined in the California Penal Code section 830, and all sections and sub-sections. Additionally, those persons who are law enforcement agents of the Federal Government and defined as such to enforce the laws of the United States, and those persons defined as law enforcement officers by statute of their state, within the United States, are allowed to attend these meetings of the CGTF. I affirm and acknowledge that any other persons who are not defined within the above categories, who wish to be brought to the meeting as a GUEST must be acknowledged by either the Coordinator or member(s) of the Board of Directors, PRIOR to the meeting. Those persons not invited and/or cleared for attendance at the meeting will be denied access to the meeting. Attorneys will be allowed to attend ONLY if they are a prosecuting attorney, and their presence at the meeting has been cleared by the Coordinator PRIOR to the meeting date.

I understand the CGTF function is to bring together such personnel for the purpose of information sharing about these gang's affiliates and activities.

I understand that those persons providing copies of the meeting handout(s) to persons not defined as peace officers, Federal Agents, or who would be allowed to attend the CGTF meeting as enumerated above, will lose their membership and will not be allowed to attend any further meeting of the CGTF.

I understand that no audio or visual recordings shall be made of the CGTF meetings or membership without prior approval.

I swear or affirm I shall abide by the provisions set forth in the Memorandum of Understanding. I agree that if I fail to so abide, my CGTF membership/guest status may be revoked.
